**Petition for The Removal of
Yomba Shoshone Tribal Chairman
(DARRYL BRADY)-Lame Duck
Term-2020-2023**

We, the undersigned eligible voters of the Yomba Shoshone Tribe, in accordance with the Yomba Shoshone Tribal Constitution and By-Laws (**Article V. Sec-3) Vacancies and Removal of Office**) do hereby submit the following petition to the Yomba Shoshone Tribal Council & Acting Superintendent of the Bureau of Indian affairs for the removal of Darryl Brady, Chairman (lame duck) for the following reasons:

1. **Failure to uphold and defend the Constitution and By-Laws** as stated and signed in his Oath of Office. The decisions Chairman, Darryl Brady has made are **NOT** in the best interest of the Yomba Shoshone Tribe or its Tribal Members.

2. **Neglect of Duties and Abuse of Office:**

a.) Tribal Chairman, Darryl Brady has refused to hold regular council meetings for the last two (2) years. (See attached mtg notices (A.) These council meetings are imperative in order to keep the operations of the Yomba Tribe effective along with the tribe's government to government connection.

Article X-section 4: Duties of Officers, and Meetings: "Regular meetings of the Tribal Council shall be held EVERY MONTH. Three members of the Tribal Council shall constitute a quorum, and is REQUIRED to conduct official business. All meetings shall be conducted in accordance with the Rules of Order Ordinance approved by the Tribal Council."

b.) Tribal Chairman, Darryl Brady continues to withhold all communication from the Yomba Tribal Council. He has reached out to tribal and governmental entities declaring them to withhold information from the Yomba Tribal Council, as well. (See attached letter (B).)

Article X-section 1: Duties of Officers, and Meetings: "The Chairman of the Tribal Council shall exercise any delegation of authority APPROVED BY THE TRIBAL COUNCIL. He/ She preside over all meetings of the Tribal Council and vote ONLY IN CASE OF A TIE. he/she shall oversee the day-to-day operations of the Tribe."

c.) Tribal Chairman, Darryl Brady has consciously exercised decision making (*acting on his own*), such as hiring attorneys, holding meetings with government officials, (*conducting Tribal business during the Tribal, "shut down" without council knowledge*) and signing illegal resolutions, and letters on behalf of the Yomba Tribal council, without the knowledge or inclusion of any of the sitting Tribal Council Members.

(See attached resolution (C.)

Article XI-section 3: Ordinances and Resolutions: "All questions or procedures shall be decided by a motion, second, and voted on by the Tribal Council. All ordinances', resolutions, or motions, the Tribal Council shall act by majority vote, but all matters of importance shall be fully discussed and a reasonable attempt made to secure a unanimous agreement."

Article VI-section 1: Duties and Powers of the Tribal Council: "The Yomba Shoshone Tribe shall exercise the following powers subject to applicable Federal/Tribal statues, Federal Court Decisions, and this Constitution."

d.) Tribal Chairman, Darryl Brady is personally responsible for the "SHUT DOWN" of the Yomba Shoshone Tribe. The decision to "Shut Down" the Yomba Tribe has not been discussed with the Tribal Council, community members, and most importantly it's TRIBAL MEMBERS. (See attached notices (D.) There has been no explanation or reason as to why this decision was made.

Article XI-section 1: Ordinances and Resolutions: "All FINAL decisions of the Tribal Council on matters of general and permanent interest to the members of the Tribal shall be embodied in ordinances shall be posted for information and education to members of the Tribe."

Article XI-section 3: Ordinances and Resolutions: "All questions or procedures shall be decided by a motion, second, and voted on by the Tribal Council. All ordinances', resolutions, or motions, the Tribal Council shall act by majority vote, but all matters of importance shall be fully discussed and a reasonable attempt made to secure a unanimous agreement."

e.) Tribal Chairman, Darryl Brady has neglected his duties as Chairman and delegated and all his Tribal Chairman responsibilities and Tribal business roles to Blair Smith. No documents are to be handed to the Chairman for any signatures without her knowledge. (see attached notice (E)

Article X-section 1: Duties of Officers, and Meetings: "The Chairman of the Tribal Council shall exercise any delegation of authority APPROVED BY THE TRIBAL COUNCIL. He/ She preside over all meetings of the Tribal Council and vote ONLY IN CASE OF A TIE. he/she shall oversee the day-to-day operations of the Tribe."

Article X-section 3: Duties of Officers, and Meetings: "The Secretary/Treasurer shall exercise any delegation of authority APPROVED BY THE TRIBAL COUNCIL. He/ She shall keep a complete, and accurate record of all matters transacted at Tribal Council meetings."

Article XI-section 3: Ordinances and Resolutions: "All questions or procedures shall be decided by a motion, second, and voted on by the Tribal Council. All ordinances', resolutions, or motions, the Tribal Council shall act by majority vote, but all matters of importance shall be fully discussed and a reasonable attempt made to secure a unanimous agreement."

3. Gross Misconduct:

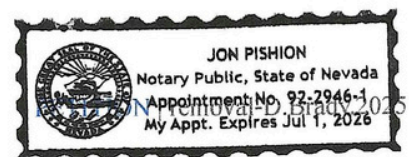
a.) Tribal Chairman, Darryl Brady has illegally sold possessions belonging to the Yomba Shoshone Tribe. The Tribe's property was NOT Chairman, Darryl Brady's personal items to sale. These items were taken off Tribal property while the Tribe was "Shut Down" by NON-members of the community along with BIA Law enforcement. There has been NO account for the money that was received for the Tribe's possessions. Furthermore, there has been NO account for Tribal funding or for Chairman, Darryl Bradys actions against the tribe and its members. (See attached pics (F.)
