RESOLUTION OF THE GOVERNING BODY OF THE YOMBA SHOSHONE TRIBE PENALTIES FOR VIOLATIONS AGAINST THE YOMBA SHOSHONE TRIBE RE: DARRYL BRADY

WHEREAS, the Yomba Shoshone Tribal Council is the recognized Governing Body of the Yomba Shoshone Tribe and was established to exercise the privileges and powers of self-government, to conserve and develop the Tribe's resources for the social and economic well-being of its members, and to preserve and protect the civil rights of its members; and

WHEREAS, the Yomba Shoshone Tribe is federally recognized by the United States Government and the Secretary of the Interior as a Native American Tribe, and by the power vested in the Tribal Constitution and Bylaws, the Council has the authority to manage all economic affairs and enterprises; and

WHEREAS, the Tribal Council has the responsibility to promulgate and enforce ordinances pursuant to the Constitution and Bylaws; and

WHEREAS, the Yomba Shoshone Tribal Council is the recognized Governing Body of the Yomba Shoshone Tribe and was established to exercise the privileges and powers of self-government, to conserve and develop the Tribe's resources for the social and economic well-being of its members, and to preserve and protect the civil rights of its members; and

WHEREAS, Article VI, Section 1(f) grants the Tribal Council the power to "promulgate and enforce ordinances governing the conduct of members of the Yomba Shoshone Tribe, and other Indians within the Yomba Shoshone Reservation"; and

WHEREAS, Darryl Brady, in his capacity as Tribal Chairman, authored a letter dated June 9, 2025, addressed to U.S. Congressman Mark Amodei, requesting termination of the Yomba Shoshone Tribe's federal recognition; and

WHEREAS, these actions constitute a severe violation of tribal sovereignty and governance, specifically:

1. Attempting to unilaterally terminate the Yomba Shoshone Tribe's federal recognition
2. Acting without Tribal council consent
3. Undermining the Tribe's fundamental right to self-determination; and

WHEREAS, such actions represent a fundamental breach of the trust placed in Tribal leadership;

THEREFORE IT BE RESOLVED: Darryl Brady is immediately and permanently removed from the position of Tribal Chairman. Darryl Brady is **PERMANENTLY PROHIBITED** from: holding any Tribal government position, participating in any Tribal elections, representing the Yomba Shoshone Tribe in ANY capacity, engaging in any employment with the Tribe, performing any contract work for the Tribe, communicating on behalf of the Tribe, accessing any tribal facilities, participating in any Tribal administrative or governmental processes, engaging in any decision-making related to Tribal affairs, accessing any Tribal financial or administrative systems, representing the Tribe in communications with federal, state, or local agencies. Darryl Brady is required to **IMMEDIATELY** relinquish **ALL** administrative and governmental access privileges to the Yomba Shoshone Tribal Secretary.

The newly elected Tribal Council is authorized to determine and impose additional penalties or legal actions related to these violations. The Tribal Council authorizes its legal counsel to take all necessary steps to enforce this resolution and protect Tribal sovereignty. This resolution is effective immediately and shall remain in full force until further action by the Tribal Council.
