**ORDER TO CEASE & DESIST: BLAIR SMITH, DARRYL BRADY,
LESA CAGLE, REGIS ROSSE**

December 12, 2025

RESOLUTION OF THE GOVERNING BODY OF THE YOMBA SHOSHONE TRIBE
CEASE & DESIST

WHEREAS, the Yomba Shoshone Tribal Council is the recognized Governing Body of the Yomba Shoshone Tribe and was established to exercise the privileges and powers of self-government, to conserve and develop the Tribe's resources for the social and economic well-being of its members, and to preserve and protect the civil rights of its members; and

WHEREAS, the Yomba Shoshone Tribe is federally recognized by the United States Government and the Secretary of the Interior as a Native American Tribes, and by the power vested in the Tribal Constitution and Bylaws, the Council has the authority to manage all economic affairs and enterprises including Administrative affairs; and

WHEREAS, the Yomba Shoshone Tribal Council has the responsibility to promulgate and enforce ordinances pursuant to the Constitution and By-Laws, including the personnel policy; and

WHEREAS, the Yomba Shoshone Tribal Administration Employees, Blair Smith, Lesa Cagle, and Regis Rosse have violated the Yomba Shoshone personnel policy by:

1. Refusal to cooperate with the governing body of the Yomba Shoshone Nation by interfering and further halting the order of Yomba Shoshone Tribal Council business, resulting in limiting the Yomba Shoshone Tribal Council's ability to protect and advance social welfare;
2. Insubordination and undermining the Yomba Shoshone Tribal Council for acting with legal authority without the permission of the Yomba Shoshone Tribal Council;

WHEREAS, Article VI, Section 1 of the Tribal Constitution specifically enumerates the Tribal Council's powers, including: (a) To negotiate with the Federal, State, and local governments on behalf of the Tribe; (b) To employ legal counsel to represent the Yomba Shoshone Tribe; (c) To approve or veto any sale, disposition, lease or encumbrance of tribal lands; (d) To confer with all Federal agencies, State and County Governments, and Private entities; (e) To manage all economic affairs and enterprises of the Yomba Shoshone Tribe; (f) To promulgate and enforce ordinances governing the conduct of members of the Yomba Shoshone Tribe; and

WHEREAS, multiple individuals have systematically interfered with tribal business operations, financial management, and administrative functions, including Darryl Brady, Blair Smith, Regis Rosse, and Lesa Cagle, thereby undermining the Tribe's economic and administrative integrity;

THEREFORE IT BE RESOLVED:

1. Blair Smith is hereby terminated from all Tribal employment
2. Lesa Cagel is terminated from all Tribal employment
3. Regis Rosse is terminated from all Tribal employment
4. Darryl Brady is currently in the process of being recalled from the Yomba Shoshone Tribal Council pursuant to Article V, Section 3 of the Tribal Constitution

All named individuals must immediately cease and desist all involvement in Yomba Shoshone Tribal Business. The named individuals are prohibited from accessing Tribal facilities, barred from communicating on behalf of the Tribe, required to immediately transfer all administrative access, including: physical keys, passwords, documents, financial records, and Tribal assets.

Failure to comply will result in immediate legal action.

The Tribal Council authorizes its legal counsel to take all necessary steps to enforce this resolution and protect tribal sovereignty. This resolution is effective immediately and shall remain in full force until further action by the Tribal Council.

It is hereby certified that the Yomba Shoshone Tribal Council is the governing body of the Yomba Shoshone Tribe and is composed of 5 members. 1 of whom has received a petition for removal. 3 votes constitute a majority. This resolution was adopted by an affirmative vote of (3) for and (0) against and (0) abstention on December 12, 2025.
