RESOLUTION OF THE GOVERNING BODY OF THE YOMBA SHOSHONE TRIBE

WHEREAS, the Yomba Shoshone Tribal Council is the recognized Governing Body of the Yomba Shoshone Tribe and was established to exercise the privileges and powers of self-government, to conserve and develop the Tribe's resources for the social and economic well-being of its members, and to preserve and protect the civil rights of its members; and

WHEREAS, the Yomba Shoshone Tribe is federally recognized by the United States Government and the Secretary of the Interior as a Native American Tribes, and by the power vested in the Tribal Constitution and Bylaws, the Council has the authority to manage all economic affairs and enterprises including Administrative affairs and,

WHEREAS, the Yomba Shoshone Tribal Council has the responsibility to promulgate and enforce ordinances pursuant to the Constitution and By-Laws, including the personnel policy and,

WHEREAS, the Yomba Shoshone Tribal Election Rules and Regulations state in Section A Duties of the Tribal Council (2) "The Tribal Council shall appoint an Election Board consisting of three (3) persons to serve for a term of two (2) years. Vacancies on the Election Board shall be filled by appointment of the Tribal Council at any regular or special meeting."

WHEREAS, members of the Yomba Shoshone Tribal election committee have neglected their election responsibilities as stated in the Yomba Shoshone Tribal Election Rules and Regulations in Section B, Duties of the Election Board,

THEREFORE IT BE RESOLVED: the Yomba Shoshone Tribal Council shall dissolve the Yomba Shoshone Tribal Election Board and appoint the following members: Letisha Yellowhawk, Finley Barney, Keenan Williams, and Sarah Caligiuri (Alternate).

It is hereby certified that the Yomba Shoshone Tribal Council is the governing body of the Yomba Shoshone Tribe and is composed of 5 members. 1 of whom has received a petition for removal. 3 votes constitute a majority. This resolution was adopted by an affirmative vote of (3) for and (0) against and (0) abstention on December 12, 2025.
